- **1. Pledge of Allegiance** 6:00 pm Tim led the pledge.
- **2. Minutes January 24, 2022** M/M/S Tim/Tom to approve the minutes from the January 24, 2022 Selectboard meeting. Vote 5-0-0.
- **3. Old Business** No discussion.
- **4. Community Solar** Tina Meserve gave a presentation on community solar options through ReVision Energy for the Selectboard to consider. The proposal was based on the Town paying \$78,000 annually in electrical costs and contracting for 85% of that usage. She indicated that ReVision could offer a 15% credit discount and that, if Jay and Livermore Falls were to go on together (with separate contracts), the savings could be up to 18%. The estimated savings over 20 years at 15% was approximately \$230,000. A 20-year contract would be required.
- **5. Town Meeting Warrant & Public Hearing Notice** M/M/S Lee Ann/Tom to approve the Town Meeting Warrant Order as presented. Vote 5-0-0. M/M/S Lee Ann/Tim to sign the Public Hearing Notice. Vote 5-0-0.
- **6. Aerial Photography** M/M/S Lee Ann/Tom to purchase the MrSID mosaic for \$850 to be added to the \$10,000 previously approved for aerial photography to be taken from ARPA funds. Vote 5-0-0.

- **8. Community Resilience Partnership** M/M/S Lee Ann/Tom to send a letter to the State in support of AVCOG being awarded the Community Resilience Partnership Provider Grant. Vote 5-0-0. If AVCOG is awarded the grant, they will be able to work with the Town to apply for a Community Resilience Grant.
