- **2. Public Hearing Planning Board Appointments: Daniel Ryder, Jamie Carden-Leventhal, and Cheryl-Ann Jerry** The public hearing was held. M/M/S Tim/Tom to appoint Daniel Ryder as a regular member of the Planning Board with a term to expire 9/2026 and Jamie Carden-Leventhal and Cheryl-Ann Jerry as alternate members with terms to expire 9/2028. Vote 4-0-0.
- **3. Minutes July 24, 2023 M/M/S** Tim/Tom to approve the Selectboard minutes from the July 24, 2023 meeting. Vote 4-0-0.

- **8. June 29th Storm Update, Woodman Hill Road Repair Bid and Paving –** The bid packet is ready to go out for Woodman Hill Road. There is a requirement that the bidders go out and look at the area before bidding, so they know exactly what is involved with the repairs. The bids will be due back on Friday August 25th at 4:00 p.m. Shiloh will open the bids. The Selectboard can review the bids and award the bid on Monday the 28th at their meeting.

FEMA validated over \$6 million in damages so far and paperwork is going to the President this week. The town is talking with FEMA and Mainland regarding getting the roads ready for bus routes with school starting soon. Begin Road will be getting at least temporary access for buses and this work is being done in house. Pikes will be paving repair areas instead of the proposed projects that we had for this year.

Gary asked about the sewer lines and Shiloh told the board that we are waiting on FEMA approval before scheduling that work so that we know what mitigation funds might be available.
