- **1. Pledge of Allegiance** 6:00 Tim led the pledge.
- **2. Minutes August 11, 2025 M/M/S** Gary/Tom to approve the minutes from the August 11, 2025 Selectboard meeting. Vote 5-0-0
- **3. Old Business** Shiloh informed the Selectboard that Danielle Brotherton declined the Schoolboard position. It was then offered to Jodi Cordes and she accepted the appointment.
- **4. POW/MIA Ceremony Request for Bridge Closure** Lee Ann/Tom to approve closing the Riley Road bridge on Sept. 19th at approximately 6:15 p.m. for 15 to 20 minutes for the POW/MIA ceremony. Vote 5-0-0
- **5. Dixfield Hydropower Project Information** Tom Saviello introduced Tom Brennan and Lauren Walsh to the Selectboard. They are involved with the hydropower project and Lauren is an Environmental Engineer with Cianbro. Tom and Lauren gave information to the Selectboard regarding the project. They are engaging with the communities in the area to let them know about the project. The way the facility will work is that when power supply is in excess it will pump water up. When the power supply is low they will flow water down through the turbines and produce power. It will be a closed loop system eventually. Lauren says they are in the process of a preliminary permit with FERC. Western Maine Energy Storage, a private company, is the initial developer. Tom Saviello said that he will keep the town up to date on progress.
